The undersigned upon oath deposes and states as follows: to-wit: that the affiant has been employed with the Enid Police Department in Enid, Oklahoma in Garfield County since June 23, 2016. That the affiant is currently assigned to the Patrol Division and is assigned to investigate criminal violations of State and Municipal laws.

On 03/30/2022 at approximately 10:40 p.m., I made contact with C.B. (17 years old) and his mother, Stacy Beard, in the lobby of the police department. C.B. said that he was at work at Little Caesar's, located at 1725 W Owen K Garriot Rd., in the City of Enid, County of Garfield and State of Oklahoma. He said a woman went to the drive thru and made an order for 2 pizzas and 1 crazy bread. C.B. told the woman the store was out of crazy bread, which angered the woman. The woman yelled "Are you serious!" C.B. told her again that they were out of crazy bread but if she would pull up to the window, he could get her the 2 pizzas. The woman pulled up to the window and asked C.B. "Do you want a diploma?" C.B. told her "Yes." The woman said "Listen here Nigger!" C.B. said "What?" The woman said "You heard me you fucking Nigger!" and then asked C.B. "Did that hurt you?" C.B. replied "No." The woman opened her face. C.B. turned around told his manager, Kyler, that he needed to deal with the woman and explained to him what happened. Kyler went outside and asked the woman what happened. He then told her that he was told what she did. The woman started laughing and told him "I harassed him like I always do." Kyler told her that what she did was not okay and the woman continued laughing and drove away.

C.B. was able to record video of the incident from Little Caesar's on his phone. I watched the video and saw an older, navy blue in color in the drive thru at the window. I saw an older female get out of the van, walk up to the window and hit C.B. in what appears to be his face.

On 03/31/2022 at approximately 2:30 a.m., I went to 709 N 9th street and saw a van matching the van in the video. I went and looked at the van's hood and saw this van had the same sun damage to the hood as the one in the video. I saw this van also had a moon roof like the one in the video. I went to the front door and made contact with Rachel Scheuerman. I saw that Rachel looked like the woman in the video.



I asked Rachel if she had been at Little Caesar's today and she said she had. I asked her what happened when she was there and she said that she was at the window and she was "joking around with the kid, you know how it is." She said that she teases everyone. Rachel said that she asked the kid, identified as C.B., if he wanted to learn about "Racism 101?" and he said "yeah." Rachel goes on to say that "Racism 101" is how she taught her kids about racism. Rachel said that she then called him "Nigger." Rachel then asks C.B. "did that hurt?" C.B. tells Rachel "no." Rachel said she "reached in the window and did like this." She made a motion of her hand softly hitting her cheek. Rachel told C.B. to "then get mad if somebody hits ya." Rachel said he left.

Rachel then asked "what else was I accused of doing?" I told her there was a video that shows her actually slapping him across the face and she confirmed that she did slap him. I told her that she called him the "n-word" two times. Rachel explained that she only called him that word one time. I asked her if she said "Listen here" n-word and she said no, that she said it "just like I told you." I asked Rachel if she was mad there was no crazy bread and she said no. I asked her if she asked him "are you serious?" and she said "that was at the drive up." I asked her if she asked C.B. if he "wanted a diploma?" Rachel said she did ask him "you get a diploma for the course, are you sure you want to hear it?" and he told her "yes."

Based on this information, the undersigned prays that this Honorable Court issue a finding of fact that probable cause to believe that a crime has been committed and that the defendant above named committed that crime.
